PAY ONLINE!

You can pay for many government products and services online, the same way you pay your utility, cable or other bills and online merchants.

Most federal government agencies offer a variety of online payment options, including debit card, online bill payment through your bank's website, PayPal and payments directly from your checking or savings account.

IT'S CONVENIENT, SIMPLE AND SECURE!

- **CONVENIENT:** Pay online 24/7, from anywhere using your computer, smartphone or tablet.
- **SIMPLE:** Making online payments is easy, fast and free.
- **SECURE:** The U.S. Treasury and government agencies adhere to the industry's most stringent security standards.

WHY PAY ONLINE?



IT SAVES TIME: You can make same-day payments, which means you don't have to allow time for mailing. Plus, you can also set up recurring payments.



IT'S FAST: Your payment gets processed quickly, and you don't have to worry about a check getting lost.



IT'S FREE: It doesn't cost you anything to pay online.



YOU CAN RECEIVE A CONFIRMATION OF PAYMENT: You'll have an electronic record of payment for easy, paperless record-keeping.



IT SAVES THE GOVERNMENT MONEY: Checks are expensive to process (it costs nearly eight times more to process a single paper check than an electronic payment).



YOU KNOW WHEN YOUR PAYMENT IS MADE: You can schedule your payment for a specific date. With a check, you don't know exactly when it will clear.

HOW DO I KNOW IF I CAN MAKE MY COURT ORDERED PAYMENT ONLINE?

Most government agencies accept online payments in one or more of the following ways:

- **ONLINE BILL PAYMENT:** Pay online through your bank's website. Add USDC SOUTH DAKOTA as a new biller.
 - To add us as a new biller, enter the information below.

- **PAY.GOV:** The U.S Treasury's online, mobile-friendly payment hub offers multiple payment options, including debit card, PayPal, and payments directly from your checking or savings account.

Simply go to **Pay.gov** and look for **South Dakota** in the search field.

- **FEDWIRE:** Individuals and businesses can use these services to pay US District Court directly from a checking or savings account. Talk to your bank about these payment options.
