RE: AMENDED TRANSCRIPT FEE SCHEDULE TO SIMPLIFY BATCH BILLING FOR  
REALTIME TRANSCRIPTS (**INFORMATION**)

I am writing to inform you of a recent update to the court reporter transcript fee schedule. The Judicial Conference amended the schedule at its September 2021 session to simplify the billing process for realtime court reporting. The Conference did not modify fee amounts for transcript pages.

The fee schedule amendment requires that orders for realtime transcript feeds placed on or before the day of the proceeding be batched together for billing purposes, and that subsequent orders be charged at the lowest rate assessed on the previous orders. The revised fee schedule is attached and has been posted publicly to [uscourts.gov](https://uscourts.gov).
